1	"(d) Exemptions From Licensing Requirements
2	IN CERTAIN CASES.—
3	"(1) In general.—Subject to paragraphs (2)
4	and (3), the Commission may in its discretion (by
5	rule or order), on a case-by-case basis or on the
6	basis of classes or categories of projects, grant an
7	exemption in whole or in part from the requirements
8	(including the licensing requirements) of part I of
9	the Federal Power Act to any small hydroelectric
10	power projects—
11	"(A) having a proposed installed capacity
12	of 10,000 kilowatts or less; or
13	"(B) for which a license was issued under
14	part I of the Federal Power Act (16 U.S.C. 792
15	et seq.) and that files for an exemption under
16	this subsection, if—
17	"(i) the original or new license was
18	issued after June 19, 1991;
19	"(ii) the project is in an area that has
20	not been determined to be critical to a spe-
21	cies listed as threatened or endangered
22	under section 4 of the Endangered Species
23	Act of 1973 (16 U.S.C. 1533) as of the
24	date of the filing for an exemption under
25	this subsection;

1	"(iii) the project has an installed ca-
2	pacity of 15 megawatts or less; and
3	"(iv) an exemption issued by the Com-
4	mission under this subsection does not
5	take effect until the expiration of the exist-
6	ing license.
7	"(2) Requirements.—The exemptions granted
8	under subparagraphs (A) and (B) of paragraph (1)
9	shall be subject to the same limitations (to ensure
10	protection for fish and wildlife as well as other envi-
11	ronmental concerns) as those which are set forth in
12	subsections (c) and (d) of section 30 of the Federal
13	Power Act with respect to determinations made and
14	exemptions granted under subsection (b) of such sec-
15	tion 30; and subsections (c) and (d) of such section
16	30 shall apply with respect to actions taken and ex-
17	emptions granted under this subsection.
18	"(3) Effects.—Except as specifically provided
19	in this subsection, the granting of an exemption to
20	a project under this subsection shall in no case have
21	the effect of waiving or limiting the application (to
22	such project) of the second sentence of subsection
23	(b) of this section.".
